## B. Client Money Standing Authority 客戶款項常設授權

Client hereby gives this Client Money Standing Authority ("Standing Authority") to Emperor Securities Limited and/or Emperor Futures Limited (collectively called "Emperor"). This Standing Authority covers all monies, assets (including any interest or dividends derived from the holding of the money or assets) in one or more segregated account(s) on my/our behalf ("Monies"). Unless otherwise defined, all the terms used in this authorization letter shall have the same meanings in the Securities and Futures Ordinance and the Securities and Futures (Client Money) Rules as amended from time to time. Segregated account(s) including any account(s) designated as client account(s) established and maintained in or outside Hong Kong.
