### INTRODUCTION

The purpose of this circular is to provide you with information regarding certain resolutions to be proposed at the AGM for the approval of (i) re-election of Directors; and (ii) granting of general mandates to issue new Shares and buy back Shares and to give you the Notice of AGM.

### ANNUAL GENERAL MEETING

The Notice of AGM is set out from pages AGM-1 to AGM-5 of this circular. Resolutions to be proposed at the AGM include, *inter alia*, (A) re-election of Directors; and (B) general mandates to issue new Shares and buy back Shares.

As at the Latest Practicable Date, to the best of the Directors' knowledge, information and belief, having made all reasonable enquiries, no Shareholder is required to abstain from voting on any resolutions to be proposed at the AGM.

In accordance with Rule 13.39(4) of the Listing Rules, all votes of the Shareholders on the proposed resolutions at the AGM shall be taken by poll. An announcement will be made by the Company following the conclusion of the AGM to inform the Shareholders of the poll results of the AGM.

In order to qualify for the right to attend and vote at the AGM, all transfer documents accompanied by the relevant share certificates must be lodged for registration with the Company's Hong Kong branch share registrar, Union Registrars Limited at Suites 3301-04, 33/F., Two Chinachem Exchange Square, 338 King's Road, North Point, Hong Kong before 4:30 p.m. on Friday, 20 February 2026 (record date). The register of members of the Company will not be closed for the purpose of ascertaining the right of the Shareholders to attend and vote at the AGM.

**No refreshments will be served and no corporate gifts will be distributed at the AGM.**

The Company would like to encourage the Shareholders to exercise their rights to vote at the AGM by appointing the Chairperson of the AGM as their proxy to represent them by returning their forms of proxy by the time specified herein. Physical attendance at the AGM by the Shareholders is not necessary for the purpose of exercising their voting rights.

### **(A) RE-ELECTION OF DIRECTORS**

#### **(I) Retirement and re-election of Directors**

In accordance with Bye-law 83(2) of the Bye-laws, Mr. Chu Raymond ("Mr. Chu"), who was appointed as Director by the Board with effect from 1 January 2026, shall hold office until the next following annual general meeting of the Company after his appointment and shall then be eligible for re-election at that meeting. Mr. Chu offers himself for re-election at the AGM.

In accordance with Bye-law 84(1) and 84(2) of the Bye-laws, Ms. Fan Man Seung, Vanessa ("Ms. Fan") and Mr. Wong Tak Ming, Gary ("Mr. Wong") shall retire by rotation at the AGM. Both of them, being eligible, shall offer themselves for re-election at the AGM.

Details of the above Directors who offer themselves for re-election at the AGM are set out in Appendix I to this circular as required to be disclosed under the Listing Rules.

#### **(II) Recommendations of the Nomination Committee**

The Nomination Committee had reviewed the biographical details of Mr. Chu, Ms. Fan and Mr. Wong and their meeting of nomination criteria (including but not limited to, character and integrity, professional qualifications, skills, knowledge and experience that are relevant to the Company's business and corporate strategy, enough time commitment to effectively discharge duties as Board member) as set out in the nomination policy of the Company and considered the diversity aspects (including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of services) as set out in the diversity policy of the Company, and took the view that all of them committed to their role as Directors.

The Nomination Committee had also assessed the independence of Mr. Wong based on his confirmation of independence with reference to the criteria as set out in Rule 3.13 of the Listing Rules and was satisfied with his independence.

The Board, having considered the recommendation of the Nomination Committee, accepted the nomination by the Nomination Committee for recommending the Shareholders to re-elect Mr. Chu (after his appointment by the Board), Ms. Fan and Mr. Wong as Directors at the AGM. Ms. Fan and Mr. Wong abstained from voting on the relevant resolution at the Board meeting regarding his/her own re-election.

### **(B) GENERAL MANDATES TO ISSUE NEW SHARES AND BUY BACK SHARES**

#### **(I) General mandates granted at the last annual general meeting of the Company held on 27 February 2025 (“2025 AGM”)**

At the 2025 AGM, ordinary resolutions were passed, among other things, to grant general mandates to the Directors to:

- (i) issue up to 20% of the aggregate number of the Shares then in issue (i.e. a maximum of 1,348,169,144 Shares) (“**Previous Issue Mandate**”);
- (ii) buy back up to 10% of the aggregate number of the Shares then in issue (i.e. a maximum of 674,084,572 Shares) (“**Previous Buy-back Mandate**”); and
- (iii) extend the Previous Issue Mandate by an additional number of the Shares bought back by the Company pursuant to the Previous Buy-back Mandate.

No Shares had been issued nor bought back by the Company pursuant to the above mandates.

#### **(II) Proposed refreshment of the general mandates at the AGM**

The previous mandates granted at the 2025 AGM will lapse at the conclusion of the AGM. It is therefore proposed by the Board to seek approval from the Shareholders at the AGM to grant fresh general mandates to the Directors.

As at the Latest Practicable Date, there were 6,740,845,724 Shares in issue. At the AGM, ordinary resolutions will be proposed to effect the following general mandates:

- (A) the Issue Mandate to allot, issue and deal with the Shares (including any sale and transfer of treasury shares) of up to an aggregate of not exceeding 20% of the total number of the issued Shares (excluding treasury shares, if any) as at the date of passing such resolution at the AGM (i.e. of not exceeding 1,348,169,144 Shares assuming no further Shares will be issued or bought back between the Latest Practicable Date and the date of the AGM);
- (B) the Buy-back Mandate to buy back the Shares of up to an aggregate of not exceeding 10% of the total number of the issued Shares (excluding treasury shares, if any) as at the date of passing such resolution at the AGM (i.e. of not exceeding 674,084,572 Shares assuming no further Shares will be issued or bought back between the Latest Practicable Date and the date of the AGM); and
- (C) the Extension Mandate to increase the total number of the Shares which may be allotted and issued under the Issue Mandate by an additional number of the Shares which may be bought back under the Buy-back Mandate.

An explanatory statement containing the particulars required by the Listing Rules to enable the Shareholders to make an informed decision on whether to vote for or against the proposed Buy-back Resolution is set out in Appendix II to this circular.

### RECOMMENDATION

The Directors are of the opinion that the proposed resolutions for (A) re-election of Directors; and (B) general mandates to issue new Shares and buy back Shares are in the best interests of the Company and the Shareholders as a whole. The Directors recommend the Shareholders to vote in favour of all relevant resolutions as set out in the Notice of AGM.

The following are the particulars of the Directors proposed to be re-elected at the AGM:

**Mr. Chu Raymond**

*Executive Director and Chief Executive Officer*

Mr. Chu, aged 59, joined the Group as the Chief Executive Officer in September 2025 and was appointed as an Executive Director and a member of the Executive Committee of the Company in January 2026. He is responsible for the Group's business strategic planning and overseeing various projects of the Group. He is also a director of several subsidiaries of the Company and a responsible officer under the SFO of Crosby Securities Limited, a subsidiary of the Company. Mr. Chu has over 30 years in the financial industry. Prior to joining the Group, he was an executive director and the chairman of the board of Quali-Smart Holdings Limited (Stock Code: 1348) from 2015 to 2025 and prior to that he was the managing director and head of Sales and Trading Division of Guosen Securities (Hong Kong), the managing director (Equity Derivatives Trading, Institutional Equity Asia Pacific) of The Bank of Nova Scotia from May 2010 to November 2011 and held senior positions with a number of reputable financial institutions between 2002 and 2010. Mr. Chu obtained a Bachelor's Degree of Science in Business Administration (International Business) from The California State University, the United States of America.

The term of service of Mr. Chu is subject to retirement by rotation at the annual general meetings of the Company at least once every 3 years in accordance with the Bye-laws and the Listing Rules. Mr. Chu is entitled to receive a Director's fee of HK\$100,000 per annum which was recommended by the Remuneration Committee of the Company and determined by the Board as authorized by the Shareholders at the annual general meeting, with reference to the market rate and the duties and responsibilities undertaken by him. Mr. Chu has also entered into an employment contract with the Group in relation to his service as chief executive officer of the Company with no fixed terms, but shall be terminable by either party upon giving one month's notice. Mr. Chu is also entitled to a basic monthly salary of HK\$270,000 and a performance bonus at the discretion of the Board and the Remuneration Committee of the Company with reference to the performance of the Company and Mr. Chu and the market benchmark.

Save as disclosed above, Mr. Chu did not (i) hold any directorships in other listed public companies in the last 3 years; (ii) have any relationship with any Director, senior management or substantial or controlling shareholder of the Company; or (iii) have any interest in the Shares within the meaning of Part XV of the SFO as at the Latest Practicable Date.

Save as disclosed above, the Board is not aware of any other information that is required to be disclosed pursuant to Rule 13.51(2) of the Listing Rules or any other matters that need to be brought to the attention of the Shareholders in relation to the proposed re-election of Mr. Chu.

**Ms. Fan Man Seung, Vanessa***Executive Director*

Ms. Fan, aged 63, joined the Group in December 2022. She is an Executive Director, the Chairperson of the Corporate Governance Committee as well as a member of the Executive Committee and the Remuneration Committee of the Company. Ms. Fan has over 35 years of corporate management experience in diversified businesses ranging from financial and securities services, property investment and development, hotel and hospitality, retailing of watch and jewellery, wholesaling and retailing of furniture, cinema development and operation to entertainment production and investment, artiste management as well as media and publication. Ms. Fan is currently a director of Emperor International Holdings Limited (Stock Code: 163), Emperor Entertainment Hotel Limited (Stock Code: 296), Emperor Watch & Jewellery Limited (Stock Code: 887), Emperor Culture Group Limited (Stock Code: 491), Ulferts International Limited (Stock Code: 1711) and New Media Lab Limited (Stock Code: 1284), all being listed members of Emperor Group. She is a lawyer by profession in Hong Kong and a qualified accountant, and holds a Master's Degree in Business Administration.

The term of service of Ms. Fan is subject to retirement by rotation at the annual general meetings of the Company at least once every 3 years in accordance with the Bye-laws and the Listing Rules. Ms. Fan is entitled to receive a Director's fee of HK\$100,000 per annum which was recommended by the Remuneration Committee of the Company and determined by the Board as authorized by the Shareholders at the annual general meeting, with reference to the market rate and the duties and responsibilities undertaken by her.

As at the Latest Practicable Date, Ms. Fan held 337,042,286 share options under the share option scheme of the Company, entitling her to subscribe for 337,042,286 Shares (representing approximately 5.00% of the total issued Shares) within the meaning of Part XV of the SFO.

Save as disclosed above, Ms. Fan did not (i) hold any directorships in other listed public companies in the last 3 years; (ii) have any relationship with any Director, senior management or substantial or controlling shareholder of the Company; or (iii) have any interest in the Shares within the meaning of Part XV of the SFO as at the Latest Practicable Date.

Ms. Fan was a director of H Cinematic Limited ("H Cinematic"), a company incorporated in Hong Kong and was primarily engaged in cinema operation in Hong Kong. A resolution has been passed on 13 December 2024 to wind up H Cinematic by way of creditor's voluntary liquidation. The liquidation is still in the process.

Ms. Fan was also a director of 英皇 娛藝影院(廣東)有限公司 (Emperor UA Cinemas (Guangdong) Company Limited) (“**Emperor UA Cinemas**”), a company established under the PRC laws and was primarily engaged in cinema operation in the PRC. Emperor UA Cinemas’ insolvency liquidation application was filed on 14 March 2023 and was completed on 29 December 2023.

Ms. Fan confirmed that she was not a party to the above liquidations and is not aware of any actual or potential claim that has been or will be made against her because of such liquidations.

Other than as aforesaid, the Board is not aware of any other information that is required to be disclosed pursuant to Rule 13.51(2) of the Listing Rules or any other matters that need to be brought to the attention of the Shareholders in relation to the proposed re-election of Ms. Fan.

**Mr. Wong Tak Ming, Gary**

*Independent Non-executive Director*

Mr. Wong, aged 50, joined the Board in February 2022. He is the Chairman of the Remuneration Committee as well as a member of the Audit Committee and the Nomination Committee of the Company. He now runs a professional accountancy firm in Hong Kong and has over 20 years of experience in the field of auditing and accounting. Mr. Wong is a certified public accountant (practising), a fellow member of the Institute of Chartered Accountants in England and Wales, the Hong Kong Institute of Certified Public Accountants and the Association of Chartered Certified Accountants and The Taxation Institute of Hong Kong.

The term of service of Mr. Wong is subject to retirement by rotation at the annual general meetings of the Company at least once every 3 years in accordance with the Bye-laws and the Listing Rules. Mr. Wong is entitled to receive a Director’s fee of HK\$150,000 per annum which was recommended by the Remuneration Committee of the Company and determined by the Board as authorized by the Shareholders at the annual general meeting, with reference to the market rate and the duties and responsibilities undertaken by him.

Mr. Wong did not (i) hold any directorships in other listed public companies in the last 3 years; (ii) have any relationship with any Director, senior management or substantial or controlling shareholder of the Company; or (iii) have any interest in the Shares within the meaning of Part XV of the SFO as at the Latest Practicable Date.

Save as disclosed above, the Board is not aware of any other information that is required to be disclosed pursuant to Rule 13.51(2) of the Listing Rules or any other matters that need to be brought to the attention of the Shareholders in relation to the proposed re-election of Mr. Wong.

**EXERCISE OF THE BUY-BACK MANDATE**

As at the Latest Practicable Date, the total number of Shares in issue was 6,740,845,724. Subject to the passing of the Buy-back Resolution and on the basis that no further Shares are issued or bought back by the Company prior to the AGM, the Company would be allowed under the Buy-back Mandate to buy back a maximum of 674,084,572 Shares (representing 10% of total number of issued Shares (excluding treasury shares, if any)) during the period from the date of the AGM up to:

- (i) the conclusion of the next annual general meeting of the Company;
- (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Bye-laws or any applicable laws to be held; or
- (iii) the revocation or variation of the Buy-back Mandate by ordinary resolution of the Shareholders in general meeting of the Company,

whichever occurs first.

**REASONS FOR THE BUY-BACK**

The Directors believe that it is in the best interests of the Company and the Shareholders for the Directors to have a general authority from the Shareholders to enable the Company to buy back Shares in the market. Such buy-back may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value and/or the earnings per Share. On the other hand, Shares bought back and held by the Company as treasury shares may be resold on the market at market prices to raise funds for the Company, or transferred or used for other purposes, subject to compliance with the Bye-laws, the applicable laws of Bermuda and the Listing Rules. Buy-back of Shares will only be made when the Directors believe that such buy-back will benefit the Company and the Shareholders.

**FUNDING OF BUY-BACK**

Any buy-back will only be funded out of funds of the Company legally available for the purposes in accordance with the Bye-laws and the applicable laws of Bermuda. The Company will not buy back the Shares on the Stock Exchange for a consideration other than cash or for settlement otherwise than in accordance with the trading rules of the Stock Exchange from time to time.

There might be an adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in its latest published audited accounts contained in the annual report of the Company for the year ended 30 September 2025) in the event that the proposed Buy-back Mandate, if so approved, were to be exercised in full at any time during the proposed buy-back period. However, the Directors do not propose to exercise the Buy-back Mandate to such an extent as would, in the circumstances, have an adverse effect on the working capital requirements of the Company or its gearing levels, which in the opinion of the Directors, are from time to time appropriate for the Company.

#### **EFFECT OF THE TAKEOVERS CODE**

If as a result of a share buy-back by the Company, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition of voting rights for the purpose of the Takeovers Code. Accordingly, a Shareholder or group of Shareholders acting in concert could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rules 26 and 32 of the Takeovers Code.

As at the Latest Practicable Date, Emperor Capital Group Holdings Limited ("Emperor Capital Group Holdings") held 2,879,521,438 Shares, representing approximately 42.72% of the total number of the issued Shares. In the event that the Directors exercise in full the power to buy back Shares which is proposed to be granted pursuant to the Buy-back Resolution, then (assuming such shareholding as at the Latest Practicable Date otherwise remains the same) the shareholding of Emperor Capital Group Holdings in the Company would increase to approximately 47.46% of the total number of the issued Shares. The Directors consider that such an increase would give rise to an obligation on the part of Emperor Capital Group Holdings to make a mandatory offer under Rule 26 of the Takeovers Code.

The Directors will exercise the power conferred by the Buy-back Mandate to buy back Shares in the circumstances which they deem appropriate for the benefits of the Company and the Shareholders as a whole. The Directors have no present intention to exercise the Buy-back Mandate to the extent that it would result in a requirement for Emperor Capital Group Holdings to make a mandatory offer under the Takeovers Code.

**GENERAL**

None of the Directors nor, to the best of their knowledge, having made all reasonable enquiries, any of their respective close associates (as defined in the Listing Rules) have any present intention to sell any Shares to the Company in the event that the Buy-back Mandate is approved by the Shareholders.

The Directors will exercise the Buy-back Mandate in accordance with the Listing Rules and the applicable laws of Bermuda.

The Company has not bought back any Shares, whether on the Stock Exchange or otherwise, in the 6 months preceding the Latest Practicable Date.

No core connected person (as defined in the Listing Rules) of the Company has notified the Company of a present intention to sell Shares to the Company or has undertaken not to do so in the event that the Buy-back Mandate is approved by the Shareholders.

Neither this explanatory statement nor the proposed Buy-back Mandate has any unusual features.
