



AFE Alert Pro Mobile App User Manual

Client can download and register the AFE Alert Pro mobile app to obtain the one-time-password needed during the login procedures of security trading platform.

*Internet connection is required for the use of AFE Alert Pro mobile app; If it is used overseas, the roaming service will be charged by the local or client's telecommunication company.

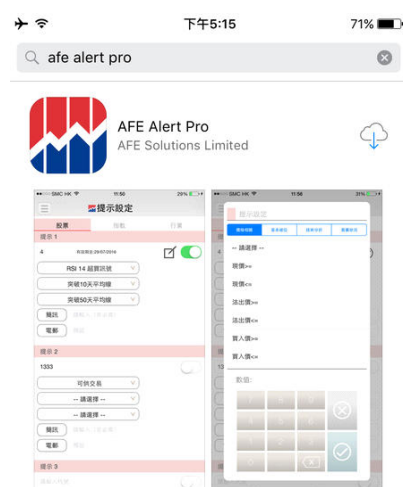

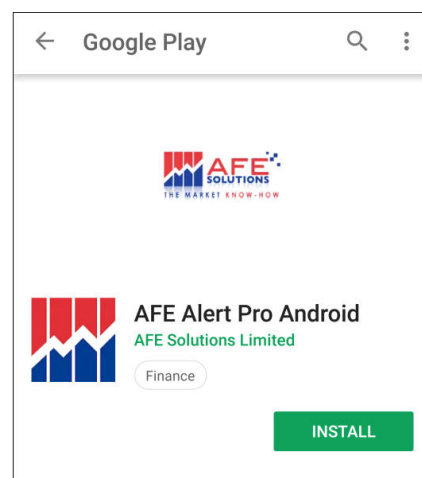

Step 2

Register the AFE Alert Pro user by clicking the “Create Account” and input the login ID, password, mobile phone number (Please include the **country code** as well, e.g. 852xxxxxxx for HK number and 86xxxxxxxxxxx for China number, etc) and email.

*the login ID for AFE Alert Pro is not necessarily the same as your client ID, however the mobile phone number must be the **same as the registered mobile number** in our company, otherwise the whole registration cannot be completed

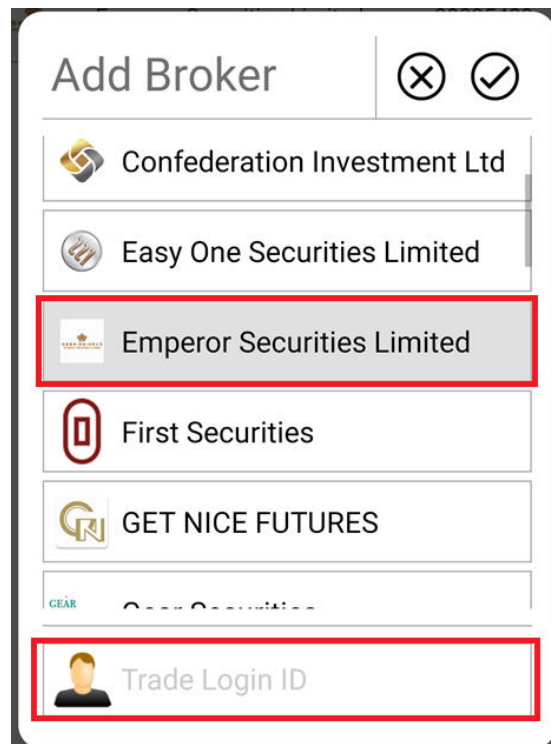
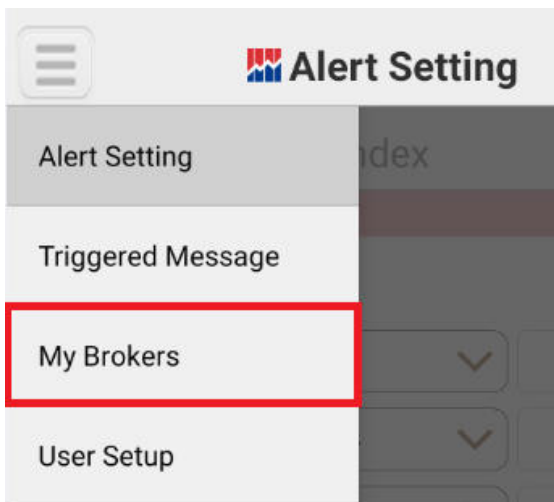
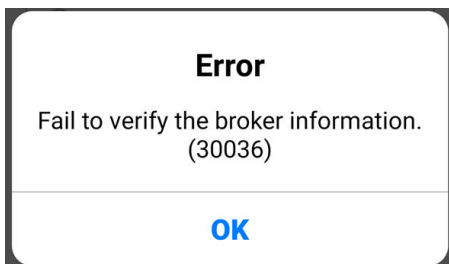

Step 4

After successfully registered the AFE Alert Pro user, please click on the “☰” in the top-left-hand corner and select “My Brokers”.

Click the “+” in the top-right-hand corner to select “**Emperor Securities Limited**” from the list and **input your account number (e.g. 800xxxxx or 000xxxxx, etc.)** in the highlighted field. Click on “☑” in the top-right-hand corner to continue. If the account number does not match with the mobile phone number set in Step 1, the following error will appear:

Another SMS will be sent for verification. "Registration Success" will be shown if the verification is completed.

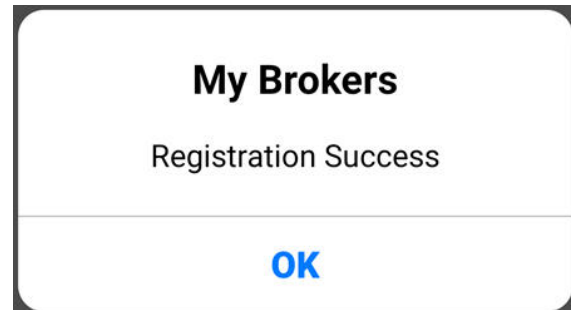

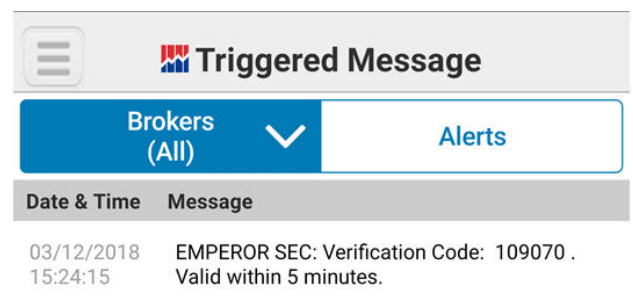
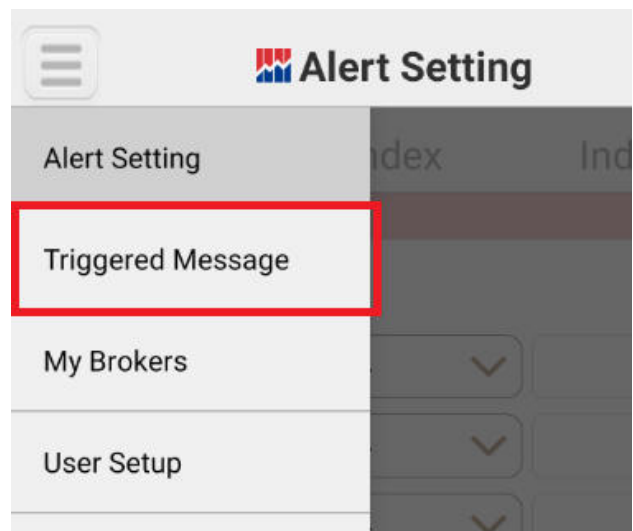
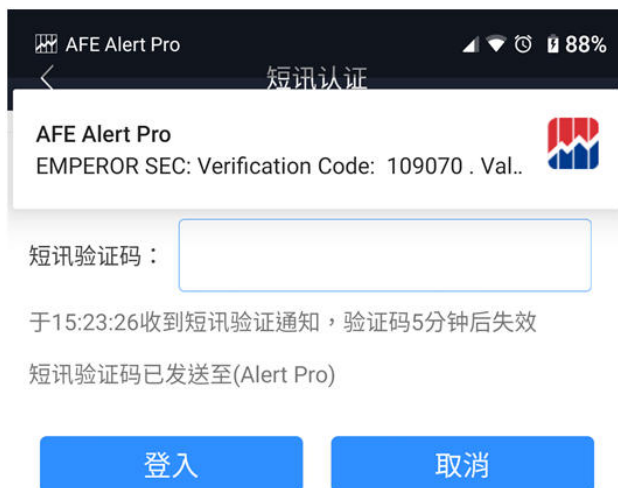
Client can repeat steps 4 and 5 to register multiple accounts in Emperor Securities Limited (given that registered mobile number of those accounts are identical)

After update when client login the securities trading platform, a one-time-password will be pushed to client's mobile as shown below. Or client can choose to goto AFE Alert Pro app, click the “☰” in the top-left-hand corner and select “Triggered Message” to check the one-time-password.

2. One account can only be registered on one smartphones. If client has more than one smartphones, or is required to switch to new smartphones, please login the AFE Alert Pro account setup in Step 2. If client fails to remember the login id and password, please choose “Forget Password” at the login page to reset the password.
